**Why is Speaker of House Pelosi Refusing to send the
Articles of Impeachments to the Senate?**

Lk, 23 1-24

1 And the whole multitude of them arose, and led him unto Pilate. 2 And they began to accuse him, saying, We found this fellow perverting the nation, and forbidding to give tribute to Caesar, saying that he himself is Christ a King. 3 And Pilate asked him, saying, Art thou the King of the Jews? And he answered him and said, Thou sayest it. 4 Then said Pilate to the chief priests and to the people, I find no fault in this man. 5 And they were the more fierce, saying, He stirreth up the people, teaching throughout all Jewry, beginning from Galilee to this place. 6 When Pilate heard of Galilee, he asked whether the man were a Galilaean. 7 And as soon as he knew that he belonged unto Herod's jurisdiction, he sent him to Herod, who himself also was at Jerusalem at that time. 8 And when Herod saw Jesus, he was exceeding glad: for he was desirous to see him of a long season, because he had heard many things of him; and he hoped to have seen some miracle done by him. 9 Then he questioned with him in many words; but he answered him nothing. 10 And the chief priests and scribes stood and vehemently accused him. 11 And Herod with his men of war set him at nought, and mocked him, and arrayed him in a gorgeous robe, and sent him again to Pilate. 12 And the same day

Pilate and Herod were made friends together: for before they were at enmity between themselves. 13 And Pilate, when he had called together the chief priests and the rulers and the people, 14 Said unto them, Ye have brought this man unto me, as one that perverteth the people: and, behold, I, having examined him before you, have found no fault in this man touching those things whereof ye accuse him: 15 No, nor yet Herod: for I sent you to him; and, lo, nothing worthy of death is done unto him. 16 I will therefore chastise him, and release him. 17 (For of necessity he must release one unto them at the feast.) 18 And they cried out all at once, saying, Away with this man, and release unto us Barabbas: 19 (Who for a certain sedition made in the city, and for murder, was cast into prison.) 20 Pilate therefore, willing to release Jesus, spake again to them. 21 But they cried, saying, Crucify him, crucify him. 22 And he said unto them the third time, Why, what evil hath he done? I have found no cause of death in him: I will therefore chastise him, and let him go. 23 And they were instant with loud voices, requiring that he might be crucified. And the voices of them and of the chief priests prevailed. 24 And Pilate gave sentence that it should be as they required.

Introduction

In any political crisis everyone has their own political biases learned from the political pundits. Few understand that the creator Yahweh Elohim (Lord God) preordains all events (Isa. 46:10).

In this third impeachment saga there are many twists and turns.

Now the most recent saga of the 21st century impeachment of President Donald Trump 45 is House Speaker Pelosi delaying the articles of impeachment sent to the Senate for the trial.

There are two ways of looking at this delay or strategy by the house speaker Pelosi. First by examining her actions from a political standpoint and second by viewing them from a divine standpoint according to Yahweh's purpose, pattern and plan.

Did President Clinton's Impeachment

Set Up a Precedent for Trump's Impeachment?

First, few Americans understand or remember the procedures of the impeachment protocol of President Clinton 42.

Yet a precedent was setup in 1998 with President Clinton's 42 20th century impeachment process by the House of Representatives and by the Senate in 1999. See the votes for the House of Representatives for President Clinton.

Voting in the House of Representatives

Here are the results from the Clinton trial in the Senate. On February 9, after voting against a public deliberation on the verdict, the Senate began closed-door deliberations instead. On February 12, the Senate emerged from its closed deliberations and voted on the articles of impeachment. A two-thirds vote, 67 votes, would have been necessary to convict on either charge

and remove the President from office. The perjury charge was defeated with 45 votes for conviction and 55 against, and the [obstruction of justice](#) charge was defeated with 50 for conviction and 50 against.[3][38][39] Senator [Arlen Specter](#) voted "[not proved](#)"[b] for both charges,[40] which was considered by Chief Justice Rehnquist to constitute a vote of "not guilty". All 45 Democrats in the Senate voted "not guilty" on both charges, as did five Republicans; they were joined by five additional Republicans in voting "not guilty" on the perjury charge.[3][38][39]

Can Pelosi's Actions Be Viewed from a Divine Standpoint?

Now the second way to view and examine the Speaker of House withholding Articles of Impeachments from the Senate is from a Divine purpose, plan and pattern.

Was the Messiah's Trial Held Up?

Few people understand that the trial of Yahshua Messiah, whom the world calls Jesus Christ, was held up by Pontus Pilate, when he found out through interrogating the Messiah that He was from Galilee. Israel leaders charged the Messiah with sedition "2 And they began to

accuse him, saying, We found this fellow perverting the nation, and forbidding to give tribute to Caesar, saying that he himself is Christ a King. (Lk. 23:2).

Pilate found he had no jurisdiction in this trial for the Messiah was Galilaeen. So, Pilate sent him to Herod's jurisdiction where he was interrogated, who was in Jerusalem.

We see here the trial was held up temporarily due to a jurisdiction question, but was quickly resolved.

There is quite a bit of comparison or correlation in principle between the delay of Yahshua's trial and Speaker of the House Pelosi holding the Articles of Impeachment from the Senate.

Pilate held up the trial for jurisdiction reasons and because he and Herod had animosity between them (Lk. 23:12).

Is there hatred between Pelosi and Trump?

Likewise, a reporter asked the Speaker of the House if she hated President Trump. She went into a tirade and told the reporter "Don't mess with me" and said she didn't hate anybody and was Roman Catholic. The tone of her conversation would lead one to think otherwise.

It's clear that Congress is a House divided along parties lines, Democrats and Republicans, as there was a division between Herod and Pilate (Matt. 12:26) who both believed the Messiah was innocent (Lk. 22:19-20), but the leaders

of Israel believe he was guilty (Lk. 23:20-23) and demanded His execution.

The United States Constitution provides that the Senate "shall have the sole Power of **Impeachment**" (**Article I, section 2**) and that "the Senate shall have the sole Power to try all Impeachments [but] no person shall be

convicted without the Concurrence of two-thirds of the Members present" (...

Is there animosity between House and the Senate?

Yes, there is animosity between the House and the Senate as there was between Israel rulers, religious priests and Pilate and Herod showing the impeachment trial reflects the trial of Messiah. The delayed trial for impeachment also correlates with the Messiah's delayed trial.

Finally, one may ask why was the Messiah's trial delayed because of jurisdiction issue? Remember in Egypt the Paschal male lamb had to be without spot nor blemish before killed, roasted with fire and household had to eat the lamb (Ex. 12:5-7)

The Apostle Paul said this lamb in Egypt pointed to the Messiah's death. So the purpose of Pilate and Herod was to find no fault with the Messiah and later Crucify Him.

This fulfilled Isaiah 53:7 wrote: *“He was oppressed and He was afflicted, Yet He opened not His mouth; He was led as a **lamb** to the **slaughter**, And as a sheep before its shearers is silent, So He opened not His mouth.”*

Conclusion

This impeachment trial of President Trump 45 is a repeat of the circumstances of Yahshua the Messiah's trial and what happened afterwards more on this later. Solomon said there's nothing new about the sun.
